

PA Law now requiring Background Clearances for ALL Volunteers

Dear Friends of Mountain View,

At the beginning of this year, camp was notified by our insurance carrier that the state of Pennsylvania had enacted a new law requiring background screening for all volunteers responsible for the welfare of a child, or having direct contact with children. Since the beginning of 2015, we have had numerous discussions with legal counsel, camp's state representative, government agencies, background screening companies, and much prayer to the Lord for wisdom. Camp has put into place a process that we believe will satisfy the requirements outlined in this law. We understand that this process will be expensive and has therefore agreed to bear the financial burden of screening for those individuals wishing to serve at camp. Camp's goal is to gather a sizeable pool of screened individuals so the work of the Lord at MVBC will go on unhindered. MVBC has set up secure online accounts with two state-approved agencies, Safe Hiring Solutions and PA Cogent ID, to help expedite the screening process. Required screening include:

Criminal History Record check – obtained from the PA State Police (Done via Safe Hiring Solutions) Child Abuse Clearance – obtained through the PA Dept. of Public Welfare (Done via Safe Hiring Solutions) Federal Criminal History Record – obtained from the FBI (Done via PA Cogent ID)

Pennsylvania residents who have lived in the Commonwealth continuously for the past 10 years are only required to complete the first two screenings. Pennsylvania residents living fewer than 10 years in the state, as well as all out-of-state and out-of-country individuals, must complete all three screenings. These screenings are grouped into "Part 1" and "Part 2" processes.

Part 1: Volunteer Screening via Safe Hiring Solutions (for screenings a) and b) above) Part 2: Federal Criminal History Report via PA Cogent ID (for screening c) above, including fingerprints)

We know it could take a number of weeks for the screening process to be completed. If you desire to serve at MVBC this year or might consider serving in the future, please do not delay starting this process. Beginning July 1, 2015, all volunteers desiring to serve at camp must be screened before they can serve. We believe the process should be started right away, if possible. Once screened, the cleared individual will be able to serve for 36 months. These clearances can also be used by the individual with any other ministry in Pennsylvania during that 36-month period. To begin this process, please contact Jon Stassel right away at jstassel@yahoo.com or 570-274-6979. A helpful step-by-step instruction sheet will be sent to guide you through the process. We are aware that the fingerprint portion of Part 2 may create some difficulties for out-of-state applicants. We are working with the state of Pennsylvania to find ways to remedy that issue.

The cost for most of these screenings will be around \$60 per person, with out-of-country individuals costing somewhat more and PA residents who have lived in-state for 10 years or more costing a bit less. Though MVBC has set up accounts to pay for this process, those wishing to contribute toward this expense can send tax-deductible gifts to help defray these costs.

Please share this information with those presently serving, encourage others to consider serving, and pray for the Lord's blessing at MVBC.

Up-date of "The Plan" for Future Projects

For I know the plans I have for you," says the LORD. "They are plans for good and not for disaster, to give you a future and a hope. In those days when you pray, I will listen.... -JEREMIAH 29:11-12 NLT

I am continually grateful to know that God has good plans for us, plans for a future and a hope. He surely has blessed this ministry over the years by providing campers, staff, rental groups, volunteers, health, safety, direction, finances... Even though we have made some plans, He has directed us,

modifying some of those plans, refocusing some other plans, erasing yet other plans and arranging the timing of them all.

The present: Bath House Pavilion Project: We are thankful this project is nearing completion. Tile is being laid in the bathrooms and change rooms. The food service area ceiling is done, though not the walls. We are waiting to receive a stainless steel sink, commercial stove and other pieces of equipment needed to make this area functional.

Though construction is still in progress, we are thankful that all the funds needed to complete this structure are in hand. Juggling between the necessary maintenance projects, monthly and seasonal task items, new construction, scheduled camps and rentals (requiring set-up, clean-up and food service), there is no lack of things to do. With the Lord's help, we plan to complete the Bath House Pavilion before summer camp begins, knowing that a number of rental picnics have already been contracted to use this area.

The future: Up-Dating of "The Plan": The plan is to complete the bathhouse pavilion already under construction near the pool, maintain the Stony Pine Activity Center and Hardwood Lodge dorm which are in need of vinyl siding (\$ 9,000 funds still



needed), window replacement (\$6,000 funds still needed) and restroom remodeling (\$8,000 funds still needed).

There has been some progress made in preparation to build two additional duplex cabins (\$85,000 per duplex). Originally, we had planned to start one this past

October. That plan had to be modified partly because the Bath House Pavilion project is not complete, but also due to lack of funds and available manpower. We do have building permits in hand for both additional duplexes, but not the funds. The full time staff and Board have agreed to hold off until September 2015 to break ground, and then only proceed if the funds are in place. We anticipate a financial need of \$100,000 which would allow both duplexes to be dried in before winter. The need to start this fall is urgent. If delayed, new building permits will be required, causing added expense and construction delays..

Financial Need: As the Lord supplies the needed funds and manpower, we will proceed with construction and maintenance projects. Knowing that Missions-In-Focus (our largest attended program) is scheduled for August 8-14, 2015, we plan to have the Bath House Pavilion finished and some of the Hardwood Lodge and Activity Center projects in progress. We kindly ask you to pray with us for wisdom regarding how quickly we can proceed. If you have time and would like to come and help with any or all of these projects, please let us know, so we can schedule accordingly.

Thank you for your prayers and interest in this area of the Lord's work.
